ORDER:

1. In the reference 1st read above, Government have issued revised Guidelines for implementation of Economic Support Schemes by the Telangana State Scheduled Tribes Cooperative Finance Limited (TRICOR) in continuation to the guidelines issued by erstwhile Government of Andhra Pradesh vide G.O.Ms.No.101, Social Welfare (SCP.I) Department, dated:31.12.2013 for the benefit of Scheduled Tribes.

2. In the reference 2nd read above, the Group of Ministers on Welfare with Ministers (Finance, BC Welfare & Tribal Welfare) under the chairmanship of Deputy Chief Minister (Education), Telangana state have made the recommendations with regard Economic Support Schemes being implemented by Telangana State Scheduled Tribes Cooperative Finance Limited (TRICOR) as detailed here under:

| Sl.No | Criterion | Earlier | Proposed |

| 1 | Subsidy for STs through TRICOR | 60% of the Unit Cost (or) Rs.1,00,000/- whichever is less. | Unit Cost up to Rs.1.00 laks - 80% Subsidy. Unit cost above 1.00 lakh to Rs.2.00 lakhs - 70% Subsidy. Unit cost above Rs.2.00 lakhs to Rs.10.00 lakhs - 60% of the unit cost (or) Rs.5.00 lakhs whichever is less. |

3. After careful examination of the matter, the Government here by order that the guidelines issued in the reference 1st read above shall be followed during the year 2015-16 also for implementation of Economic Support Schemes being implemented by Telangana State Scheduled Tribes Cooperative Finance Corporation Limited (TRICOR) under SCA to TSP, subject to following modifications of funding pattern as suggested by Group of Ministers on Welfare in the meeting held on 08.05.2015.

| Unit Cost | Subsidy |

| Unit Cost above Rs.1.00 lakh to Rs.2.00 lakhs | 70% |

4. In the reference 4th read above, the Special Secretary to the Hon'ble Chief Minister informed to adopt revised income criteria as desired by the Hon'ble Chief Minister. accordingly, the income eligibility criteria shall be Rs.1.50 lakhs per annum for rural areas and Rs.2.00 lakhs per annum for urban areas on par with other welfare schemes of Government i.e., Aasara, Shaadi Mubarak and KalyanaLaxmi schemes.

5. In the reference 3rd read above, the Commissioner of Tribal Welfare/Ex-Officio Managing Director, TRICOR, Hyderabad has submitted the Action Plan 2015-16 for implementation of Economic Support Schemes for the benefit of STs for a budget out lay of Rs.75.00 Cr. covering (5606) ST beneficiaries duly indicating the sector wise allocation as detailed below:
